LAW@CDC marks 10 years of Community Legal Awareness

~with new focus on Law and the Environment in 2024~

Law Awareness Weeks@CDC (LAW@CDC) 2024 will mark a decade of partnership between the five Community Development Councils (CDCs) and Pro Bono SG (PBSG). This annual flagship programme, first launched in 2015, has engaged over 15,000 participants through more than 340 legal talks that equip residents with the resources and knowledge to navigate the legal system. On top of common legal topics, this year's edition will also spotlight webinars on the theme of "Law and the Environment – Building Sustainable Communities for the Future".

- The Guest-of-Honour, Minister for Culture, Community and Youth, Second Minister for Law and People's Association (PA) Deputy Chairman, Mr Edwin Tong, SC, together with the five Mayors, will officially launch LAW@CDC 2024 on Saturday, 21 September 2024, 1pm at the Institute of Technical Education (ITE) College West. The launch event will feature a welcome address by CEO of Pro Bono Singapore, Mr Tanguy Lim; opening address by Senior Minister of State (SMS) for Culture, Community and Youth & Trade and Industry, Chairman of Mayors' Committee and Mayor of South West District, Ms Low Yen Ling; and keynote address by Minister Edwin Tong, to guests comprising pro bono lawyers, law firms, law students, and partners.
- 3 Each year, LAW@CDC spotlights an emerging need or topic of interest relevant for the community. This year, the focus on "Law and the Environment- Building Sustainable Communities for the Future" highlights the CDCs' efforts to build learning and sustainable communities. By expanding residents' understanding of environmental issues through a legal lens, LAW@CDC 2024 aims to foster a sense of collective environmental responsibility where individuals feel empowered to take ownership of their environmental impact and work together towards a more just and sustainable future. In line with the theme, LAW@CDC 2024 will feature new webinar topics such as "Legal Protections for Singapore's Biodiversity", "Furry Friends, Fair Treatment: Understanding Animal Welfare Laws", and "Combating Pollution: Towards a Greener and Better Singapore"

























- LAW@CDC is led by the five CDCs and PBSG, together with its network of partners, National University of Singapore (NUS), Singapore Management University (SMU), Singapore University of Social Science (SUSS), Singapore Corporate Counsel Association (SCCA), and Singapore Association of Social Workers (SASW). The annual programme, currently in its tenth edition, is a nationwide effort to promote awareness and knowledge of the law, educating the residents on various evergreen community legal issues, such as "Conflicts with Neighbours", "Divorce Matters and Concerns", "Dealing with Family Violence", "Advance Legal Planning on Wills and End-of-Time Matters" and more. The event also serves as a key platform for volunteer lawyers and law students to connect with and to give back to the community, bringing together more than 300 passionate lawyers and volunteers over the past decade.
