LAW@CDC INKS 2-YEAR MOU WITH NEW PARTNERS TO FORM ALLIANCE ON SCAM PREVENTION

CDCs, LSPBS, IHLs, SCCA are partnering the SPF, NCPC and NUS Pro Bono Group to create greater community awareness on scam prevention

The annual Law Awareness Weeks@CDC (LAW@CDC) will be officially launched by Guest-of-Honour Mr Edwin Tong, SC, Minister for Culture, Community and Youth & Second Minister for Law, together with the five Mayors on Sunday, 2 October 2022 at Singapore University of Social Sciences (SUSS).

Now into its 8th year, the LAW@CDC 2022 will present a series of legal talks, both physical and online, to raise awareness on the importance of equipping oneself with basic legal knowledge to manage emerging issues and disputes. With the number of reported scam cases in Singapore doubling in 2022, the theme for this year's LAW@CDC is "*Staying Cybersafe: Protecting Yourself and the Community*" to promote awareness and understanding of legal remedies for online threats. Popular hot button topics relating to divorce, employment, legacy planning, neighbour disputes, caregivers' legal rights and other common legal issues continue to be featured this year.

3 Minister Edwin Tong will deliver his keynote address to the pro bono lawyers, law firms, law students, partners and guests at the event. Host Mayor Alex Yam of North West District, and Chairman of LSPBS, Mr Gregory Vijayendran SC will also touch on the importance of building societal resilience to scams. Around 100 lawyers, law firms and partners will be given certificate of appreciation to acknowledge their steadfast contribution and support.

4 To augment collective action on scam prevention and awareness, particularly targeting the seniors and youths, the LAW@CDC 2022 partners, comprising five CDCs, LSPBS, National University of Singapore (NUS), Singapore Management University (SMU), SUSS and Singapore Corporate Counsel Association (SCCA), will be joined by the Singapore Police Force, National Crime Prevention Council (NCPC) and NUS Pro Bono Group. The event will also witness the signing of a new two-year

Memorandum of Understanding (MOU) to offer enhanced integrated care for the community beyond the annual LAW@CDC programme.

5 LAW@CDC 2022 will feature 11 webinars aired 'live' online taking place from 27 September 2022 to 27 October 2022 led by moderators and panelists comprising lawyers and respective subject matter experts. These legal talks aim to simplify legal jargons for the general audience, provide clarification and share useful resources available.
