ISLANDWIDE LAUNCH OF LAW AWARENESS WEEK (LAW) @CDC 2016

Increased number of talks: 2.3X more compared to 2015
Expanded Menu: 2X more topics

Deputy Prime Minister (DPM) and Coordinating Minister for National Security **Mr Teo Chee Hean** will launch the LAW @Community Development Council (CDC) 2016 on Saturday, 3 September 2016, 10.30am at the Waterway Point Shopping Mall. The hosts for this event will be the five Mayors and CDC Vice-Chairmen.

2 Partnering the Law Society Pro Bono Office, this is part of the five CDCs' efforts to bring useful services closer to the ground. It is the second year that the Law Awareness Week has been decentralized as previously the talks were held only at the Supreme Court.

3 Ground response has been encouraging as we see twice the number of talks being organised this year as well as many more volunteers stepping up to do pro bono work. This also shows an increase in legal awareness and its importance on the ground.

MORE ABOUT THE EVENT

What can you do if you are being cyber-bullied or stalked or how can you help a victim of harassment? Residents can find out how and where to get help when they encounter such situations at the series of talks which will be rolled out during the Law Awareness Week (LAW) @CDC 2016. The five Community Development Councils (CDCs) and Law Society have enhanced the menu of talks to include topics of interest to the residents and with more talks across the island, more residents are expected to benefit from the talks made available at community clubs.

2 Cyberbullying is among the top five topics requested for the series of legal talks this year. With the advent of the internet and rising threat of cyber bullying which has been linked to self-harm and negative impact on emotional well-being, the CDCs and Law Society hope to reach out to residents to educate them with basic knowledge of law so that they are more informed of their rights, what they can do and where they can get help. Other popular topics concerning residents' everyday needs and concerns include Advance Planning for end of life issues and Family Law.

3 During the launch event, we will share more information on the collaboration of CDCs and Law Society in LAW @CDC 2016 as well as the Community Legal Pro Bono Services Network which was launched back in September 2014 by CDCs and Law Society to assist needy Singaporeans and Permanent Residents who are seeking free legal advice. *The Community Legal Clinics have since helped many residents, one of whom is a 60-year old Indian divorcee who had been declared bankrupt but with the help of pro bono lawyers at the clinic, he was able to get back on his feet, discharged himself from bankruptcy and re-entered the workforce.*

4 Residents may sign up for legal talks through the CDCs, the Community Centres/ Clubs (CCs) and Law Society. Please refer to **Annex B** for the list of talks.
